

POLICY STATEMENT ON BEHALF OF PROTECTED VETERANS AND INDIVIDUALS WITH A DISABILITY 41 CFR §§ 60- 300.44(A), 741.44(A)

July 1, 2023

It is the policy of Veracity Consulting, Inc. (Veracity) not to discriminate against any employee or applicant for employment because he or she is a qualified individual with a disability, a disabled veteran, a newly separated veteran, a campaign veteran, or an armed forces service medal veteran (i.e., qualified protected veterans). In order to ensure dissemination and implementation of equal employment opportunity and affirmative action throughout all levels of the company, I have selected the Director of Talent as the Equal Employment Opportunity (EEO) Official for Veracity.
